Mr. Pierce called the meeting to order. The minutes from the last board meeting were reviewed and approved.

Public Comment: Mr. Pierce opened the floor for public comment; there was none.

Financial Report:

Mr. Pierce went over the financial reports and the school is in good standing. Dr. Moodie reported on the last ESSER grants that are being submitted to the district.

School Report:

Dr. Moodie gave a status report on the two campuses. The Hialeah campus is at capacity at 300 students, and the students and staff are doing well. The South Dade campus opened with 2 students and now has 3 enrolled. Applications continue to come in. The Assistant Superintendent of schools visited well and Dr. Moodi is confident enrollment will continue to grow steadily.

Staff Report:

The Hialeah campus is almost fully staffed. As the South Dade location continues to enroll, the school will need to hire specialty teachers and ESE certified teachers.

Dr. Martinez-Fernandez has provided a new board disclosure as well as her identification, and Susan Leon will request a background check on her behalf.

Susan Leon reminded all the board members of their expiration dates for their current board training, as well as their board terms and background checks.

Student Report:

Dr. Moodie gave a status report on certain behavioral issues in the school, which she was happy to report have improved. She also advised of several seizures that occurred in the school in the first few days, and she stated how proud she was of her staff's performance during these crises.

Dr. Moodie reminded the board of upcoming important dates: Ray of Hope Gala on 11/09/24, and the SFACS Walk on 4/19/25.

The next board meeting is scheduled for October 4, 2024.
